Ridpath Penthouse #1303 Mann condo unit

Narrative

The 13th floor of the Ridpath Tower housed a restaurant called variously the Ridpath Roof and later Ankeny's. Along with the rest of the Tower it was divided into a number of tax parcels in 2006. The 12th and 13th floors of the building were purchased by Ridpath Penthouse partners LLC in 2012. This application deals with the southern half of the 13th floor encompassing parcels 35191.7110-35191.7113.

In 2012 the Ankeny's space was a disaster. Restaurant equipment had been removed, some wiring and piping had been torn out, and the space had been vandalized. Work to covert this space into living space began in late 2017, with general cleanup, asbestos removal and demolition of the remaining restaurant items. The process was slow one, with work taking a period of almost three years. Application for Special Valuation was made in September 2020, so this application covers the period from September 2018 to September 2020. Total expenditures came to more than \$900,000, with some \$367,270.14 included in this application. Most of the work was done by Ron Wells Group (RWG) and Salvaged Designs (Sal Des). Payment was by check to both of these entities as well as to several smaller subcontractors.

This project involved complete buildout from a shell to a finished dwelling. External projects were limited to replacement of all the windows on the south side of the building due to unstable structure, as well as replacement of broken windows on both the east and west sides of the building. No roof replacement or repair was necessary as this had been done by the Ridpath Club Apartments project.

Interior renovations included floor levelling for installing hardwood in living areas carpet and tile. Interior walls were constructed to maintain the open floor appearance viewed from outside. Inside storefront window walls on west-facing rooms allow exterior views. Many of the girders were left exposed and coated with fire resistive intumescent paint. Rather than depend upon the hydronic heating/cooling system in the rest of the Tower, the renovation features a new high efficiency HVAC system integrated in the trussed ceiling space. Expenditures are listed chronologically in the attached spreadsheet. Individual invoices are attached, as is a floorplan.

The result is a modern living space with 3066 sq ft of living space, including two bedrooms, 2 ½ baths, two offices, and a media room. The expansive views provide a unique residential experience, unique in Spokane.
