Briefing Session: Meeting called to order at 3:33 PM by Betsy Bradley

August 17, 2022 Meeting Minutes approved unanimously.

#### 1. Old Business:

- East Central Cultural and Historic Survey Project: Megan reported that the extension on this project is good through next year. Staff has set a goal to have it completed by the end of this year.
- Cannon Streetcar Suburb Historic District Effort: Megan reported that ballots for the
  district vote were mailed last week. Preliminary documents will be provided to the
  committee in October for a vote. Megan spoke on the community efforts to engage the
  neighborhood through weekly meetings, presence at the yearly Cannon Neighborhood
  block party, and Historic District yard signs. KXLY did a video piece on the proposed new
  district. Approximately 100 ballots have been returned so far out of around 550 sent
  with most votes in favor of the proposal.

## 2. New Business:

- Upcoming Special Valuations:
  - October Wells Chevrolet (1229 W First Avenue) and Knights of Pythias Hall (1203 W Riverside Ave)
  - November Lloyd House (1325 E 20<sup>th</sup> Avenue), Solby House (1325 E 20<sup>th</sup> Avenue), and Dwinnell House and Fallout Shelter (504 W 19<sup>th</sup> Avenue)
  - Pending Application 2222 West 2<sup>nd</sup>, 925 S Cedar Street, Sengfelder-Bungay House, and Winter House
- Eastside Carnegie Library Roof: Megan reported that the Eastside Carnegie Library roof
  was replaced without permits or a certificate of appropriateness. Megan presented a
  slideshow with photos of the original roof and the new roof. Historic Preservation is
  reviewing options with legal on how to proceed.
- Manito Boulevard House Demolition: Megan reported that the house located at 2522 S
  Manito Boulevard is slated to be demolished. The house, while historic, is not listed on
  the register.

- Upcoming vacancies and current vacancies on the commission are being advertised to be filled. Megan provided information on a few people that are considering applying.
